

## Advertisement No. 1, Dated 18.06.2021

Applications are invited from eligible candidate within the age limit of 18 years to 44 as on 01.01.2021 relaxation of age for SC/ST candidates as per existing Rules will be admissible for filling up 1 (One) Post of Attached Peon and 1 (one) Post of Night Chowkidar under the establishment of the undersigned.

### The Details of Posts and Establishment:

**Establishment** : The Chief Judicial Magistrate, Golaghat.

**Place of Posting** : Office of the Chief Judicial Magistrate, Golaghat

- A candidate must possess the minimum educational qualification of Class VIII standard; and those who have been passed HSSLC or above shall be ineligible to apply for said posts. Candidates possessing special skills may be given preference on need basis.
- The applicants must submit their applications in the Standard Form of application published in the Assam Gazette Part-IX. A candidate will have to submit 4 (Four) copies of recent passport size photograph and the testimonies of his/her Age, Caste, Educational Qualification etc. along with the filled up application form, in photocopy attested by a Gazetted Officer. Candidates will have to produce those testimonies in original, in the event of being selected for interview. Failing which, his/her candidature will be summarily rejected and the next eligible candidate from the merit list will be considered. The candidate shall apply for one post only.
- Candidate shall submit one self addressed and stamped envelope affixing stamp of Rs. 10/- along with the application.
- Complete applications along with all testimonies as mentioned above should be addressed to "The Chief Judicial Magistrate, Golaghat, PIN 785621, Assam" through post or may be dropped in the "Drop Box for Applications" to be kept at the premise of Office of the Undersigned within the stipulated time.
- Last date of receipt of applications will be on 15 days from the date of advertisement till 5 p.m.
- Selection procedure as well as the date of Written Test/ interview will be notified later on.
- Applications submitted in any other mode, except as indicated and incomplete applications will be summarily rejected without any communication to the candidate.
- A List of selected candidates will be published in the website of Golaghat District Judiciary website <http://golaghatjudiciary.gov.in/>.
- Canvassing by any means will immediately lead to rejection of candidature.
- Candidates already in the Government Service should apply through proper channel.
- Selected candidates will receive their appointment letters by post at their respective postal address as specified by them in their application forms.
- Reservation belonging to different categories will be as per rules.
- The certificate for claiming reservation must be issued by the Competent Authority and the same in original must be produced before the Selection Committee at time of interview.
- Experience in the relevant field will be counted.
- The office of the undersigned reserves the right to alter/modify or change any of the terms and conditions including selection criteria etc. mentioned in the advertisement.
- The admission of candidates at all stages of the selection process will be purely provisional and subject to their satisfying the prescribed eligibility conditions by way of furnishing documentary evidence in support thereof.
