1. The candidate must be an Indian citizen as defined in Article 5 & 6 of the Constitution of India.
2. The candidate must not be less than **18 years** and more than **40 years** of age as on **01.01.2023**. The upper age- limit is relaxable by **5 years** for SC/ST(P)/ST(H) candidate and **3 years** for OBC/MOBC Candidates as per Govt. Office Memorandum ABP.6/2016/51 dated. 02.09.20.
3. Minimum qualification is **class VIII passed**. Preference will be given to candidate having professional skills, related to requirement of this establishment.
