Terms and Conditions

1. Candidates must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. Candidates already serving in Govt. Department should submit their application through proper channel.
3. Preference will be given to those candidates who are working in Judicial/Govt./Private departments and also to those having professional skills.
4. **Candidates must have passed Class VIII but Candidates who have passed H.S.S.L.C. or equivalent or above shall be ineligible to apply for the aforesaid post.**
5. If any candidate is found to have suppressed his/her educational qualifications or given wrong information at the time of applying for job, his/her candidature shall stand rejected without any information to him/her with immediate effect and shall also be liable to Criminal Prosecution as per law.


6. The candidates must have to submit a Self-Declaration Certificate ("**Annexure – A**") stating that he/she has not passed HSSLC or equivalent examination or above.
7. Candidates must not be less than 18 years of age or more than 40 years of age as on 01/01/2023. The upper age is relaxable as per Govt. norms.
8. The application with self-attested copies of all testimonials regarding Educational Qualification, Age, Caste, Valid Employment Exchange Registration Card along with 03 (three) copies of recent passport size photographs duly signed by the candidate on the reverse side should reach the office of the undersigned.
9. The applicant should mention their mobile number in the application without fail.
10. **The last date of receipt of application form is 14/08/2023 up to 5 P.M.** No application will be accepted after the last date of submission. The undersigned shall not be responsible under any circumstances for any postal delay.
11. Envelope containing application should indicate the name of the post they applied for on the top in Block letters as "**APPLICATION FOR THE POST OF OFFICE PEON**".

The list of eligible candidates along with specific date of written test/interview shall be uploaded in the official website of Chirang District Judiciary (www.chirangjudiciary.gov.in) in due course. **No separate call letters will be issued.** Applicants are advised to go through the official website regularly.

The applicants shall submit their application in a drop box made available for the same in front of the office of the Chief Judicial Magistrate, Chirang, Kajalgaon or they may submit through ordinary postal service or speed post. Application sent through registered post or private courier service will not be entertained.
