Advertisement for Hiring Specialists for DRR Roadmap Implementation cum Technical Support Unit

Background

Assam is amongst the most disaster-prone states in India. According to a study by the Ministry of Home Affairs, Government of India, the state of Assam is ranked 15th among the Indian states and union territories in terms of total population, while it is ranked 8th in the composite disaster risk index among states and union territories in India. Specific to hazard index, Assam is ranked 1st in earthquake risk index while 2nd in flood risk index as per the study¹. Due to floods, which is the most visible risk, affected 39,50,065 (3.9 million) people annually while 4,58,041 (0.45 million) people annually took shelter in relief camps between 2012-20 in Assam. In the same period, Assam suffered an annual average economic loss of Rs.1186 crore per year². Assam was ranked most climate vulnerable state of the Country as per the district level climate vulnerability assessment of India while another three NE states were among ten most climate vulnerable states³.

Recognizing the complex risk profile of the state and the urgency to adopt sustainable and effective measures, Government of Assam has come up with Assam Disaster Risk Reduction Roadmap, 2030 as a vision document for Government of Assam with the aim of preventing new risks, reducing existing risks and managing residual risks. For coordinating and providing strategic technical assistance, a DRR Roadmap Implementation-cum-Technical Support Unit will be established at the ASDMA.

The DRR Roadmap Implementation cum Technical Support Unit (TSU) will act as the Secretariat for carrying out routine coordination, capacity building, facilitation, reporting and M&E functions related to DRR Roadmap. To be housed in ASDMA, TSU will be headed by CEO, ASDMA or an Officer nominated by the State Government not below the rank of Secretary and will have experts nominated from different stakeholder groups as well as 06 Thematic Specialist covering all pillars of the DRR Roadmap to be recruited by ASDMA on contractual basis .

Roles and Responsibilities of the DRR Roadmap Implementation Technical Support Unit (TSU):

- 1. Carry out day to day business supporting the implementation of DRR Roadmap.
- 2. Create and maintain Databases of disaster induced losses and damages including updation of baseline (as per need and availability of data).
- 3. Develop notifications, advisories, and other documents as relevant to the implementation of the DRR Roadmap as per guidance of the Advisory Committee.
- 4. Develop position papers, briefing papers, thematic review papers, summary reports, and detailed progress reports on bi-annual basis or as per need under the guidance of the Advisory Committee.
