**ELIGIBILITY CRITERIA:**

Peon	The candidates must possess the minimum educational qualification of Class VIII standard passed, and those who have passed HSSLC or above shall not be eligible to apply for the said post. Preference will be given to the candidates who are working in this establishment as casual, contingent and wages employee.

**TERMS AND CONDITIONS:**

1. Candidates must submit along with the applications form, self-attested copies of relevant testimonials/certificates, 3 (three) recent passport size photographs out of

which one photograph must be pasted on the application. However, candidates have to produce their original testimonials regarding educational qualifications, date of birth, caste, working experience etc. at subsequent stages when asked for.

2. Age will be minimum 18 years and maximum will be as per Govt. of Assam Notification. Age will be counted as on 01-01-2025.
3. Applications are to be submitted in the drop box within the office working hours in Court office or by post (Address: Office of the Member, Motor Accident Claims Tribunal, Nagaon, District Judiciary complex, Pin-782001).
4. The envelope containing the application should be superscribed- **"Application for the post of Peon"**.
5. No application fee will be necessary.
6. Application form which is incomplete in any respect, such as, without photograph, signature etc., is liable to be rejected summarily without giving any information to the applicants.
7. Candidates who are already in Government Service (Central/State of PSU) may apply through proper channel. They shall have to produce "No Objection Certificate" from the present employer along with the application form.
8. Candidates shall submit a self declaration regarding their educational qualification stating that **"I have not passed HSSLC or equivalent examination and I shall be liable for criminal prosecution for submission/detection of my false educational qualification."**
9. Candidate has to submit the Employment Exchange number.
10. Information submitted by an applicant in his/her application will bind the candidate to be liable for criminal prosecution in case of false declaration.
