- 3. Post Category-wise separate lists will be prepared for each category of the post.
- 4. A candidate must not be less than 21 years of age and not more than 45 years as on 1st January, 2025.
- 5. The eligible candidates shall apply online in the official website https://avs.assam.gov.in where the link for on-line application shall shortly available. No offline application shall be accepted in this regard.
- 6. The Online Applications and documents submitted by the candidates will be verified along with their original testimonials, by the Adarsha Vidyalaya Sangathan, Assam. The detailed schedule and venue for Screening/ Verification of documents will be notified in the official website. No TA/DA is admissible for verification process. - 7. The Online Application and documents submitted by the candidate will be verified using modern technology with the help of DigiLocker, Govt. of India and by scanning Barcode or QR Code for ensuring genuineness of the uploaded documents as well as by back office verification with the competent board/council/ authority. But the authority if desires may conduct physical document verification at any point of time with proper notice.
- 8. The candidate must ensure genuineness of all the information/ documents uploaded against the online application and he/ she will be solely responsible for the information/ documents uploaded against his/ her online application. Once uploaded there will be no scope of correction in respect of the credential submitted by the candidate. Any discrepancy will lead to cancellation of the candidature.
