The filled up "Application Form" along with recent two copies of passport size photograph duly signed by the candidate on the reverse side, all copies of self attested documents like age proof certificate, educational qualification certificate, employment exchange registration certificate for the State of Assam, experience certificate if any, forwarding documents in the case of apply through proper channel shall be sent addressing to the District and Sessions Judge, Goalpara.
2. The candidates who are already in the Govt. service shall apply through proper channel.

3. Candidates must have registered their names in the employment exchange and the registration numbers along with date must be mentioned in their applications

The list of eligible candidate for interview/written test/other test shall be uploaded in the official website of Goalpara District Judiciary(<https://goalpara.dcourts.gov.in>) in due course of time. No individual call letter will be sent to eligible candidate. The date and place of Interview/other test/Viva Voce shall be notified in the above mentioned Official Website and in the Office Notice Board in due course of time.
