1. The candidate must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. The age of the candidate must not be less than 18 years of age and more than 40 years of age as on 01.01.2026. The upper age limit relaxation is 5 years for SC/ST candidates; 3 years for OBC/MOBC candidates.
3. Preference will be given to the candidates who are working in this establishment for years as wages/ casual /contingent or others.
3. The candidate who has no relevant qualification & experience need not apply.

1. The eligible candidates must submit their applications in the Standard Form published in Assam Gazette Part-IX only in offline mode. Candidates may add additional columns for mentioning their email ID, contact number, etc.
