1. The Candidate must be a Citizen of Indian as defined in Article 5 to 8 of the Constitution of India.
2. The candidate must have a valid driving license (LMV) issued from the competent authority.
3. The Candidate must be not less than 18 years and not more than 40 years of age on the date of publication of this advertisement.
4. The candidate must have driving experience of LMV for minimum 5 years.
5. Preference will be given to experienced candidates.
6. The candidate must possess minimum educational qualification, i.e., Class-X (HSLC) passed.
