General Instruction for Candidates:

1. Candidates must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. Candidates must have registered their names in the Employment Exchange and the Registration numbers along with the date must be mentioned in their applications.
3. Candidates serving in Govt. Department should submit their application through proper channel.
4. If any candidate is found to have suppressed his/her educational qualifications or given wrong information at the time or subsequent to applying for job, his/her candidature shall stand rejected without any information to him/her with immediate effect and shall also be liable to criminal Prosecution as per law.
5. Candidates must not be less than 18 years or more than 40 years of age on 01-01-2026. The upper age limit is relaxed by:-
 - a. 5 (five) years for SC/ST candidates, i.e., 45 years
