Applications are invited in **STANDARD FORM** from the suitable desirous candidates for engagement of **01 (One) no. of** (Unreserved) post of Driver purely on contractual basis in the establishment of the undersigned on Fixed Pay of Rs. 15,000/- (Fifteen Thousand) per month.

ELIGIBILITY :

1. The Candidate must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. The Candidate must have a valid LMV Driving Licence issued by the competent authority. The Driving License must be issued at least 3 years before the date of publication of this advertisement.
3. The candidates must not be less than 18 years. Age criteria shall be guided by government guidelines and the determinative date shall be 01.01.2026.
4. Minimum Qualification of the candidates must be Class-VIII (Eight) Pass.
5. Preference will be given to experienced candidates.

HOW TO APPLY:

Intending candidates will have to submit their application in Standard Form in sealed envelope to "The District Legal Services Authority, Karbi Anglong, Diphu, -782460" either personally or through post.

1. The applicants must superscribe "Application for the post of Contractual Driver" on the top of the envelope and must write their MOBILE Nos. on the top of the Standard Form respectively in red ink.

2. The applications must be accompanied with:
 - a. Two copies of recent coloured passport size photo,
 - b. Experience Certificate, if any
 - c. All SELF ATTESTED testimonials in support of their educational qualification and caste.
 - d. Copy of Driving License which is legible.
3. Candidates already in govt. service must apply through proper channel.
4. Canvassing directly or indirectly will disqualify a candidate.
5. The candidates will have to appear in the Driving Test & Interview at their own expenses and no T.A. & D.A. is admissible in this respect.
6. Incomplete application will be summarily rejected.
7. All information about date of skill test and viva-voce shall be uploaded in official website and office notice board.

SELECTION PROCEDURE:

- i) The candidates who are found to be eligible shall have to undergo skill test of 20 marks.
- ii) The candidates who qualify the skill test will be called for a viva-voce of 30 marks.

No application will be accepted after the last date and time as mentioned above. The office will not be responsible for any postal delay.


