2. The candidate must not be less than 18 years and more than 40 years of age as on 01/01/2026. Age relaxation shall be as per Govt. norms for reserved categories.
3. Minimum Qualification is class VIII (Eight) passed.
4. The candidate must have valid LMV Driving License issued by competent authority.
5. The candidate must possess valid Employment Exchange Registration number for the State of Assam.
6. If any candidate is found to have suppressed his educational qualification or given any wrong information at the time of applying for the post, his candidature shall be liable to be rejected without any notice.


16. The candidates who are already in Government Service shall apply through proper channel.
