**ELIGIBILITY CRITERIA**

1. Minimum educational qualification for the post is VIII (Eight) pass. Candidates who have passed HSSLC or above shall not be eligible to apply.
2. The candidates must possess a valid driving license (LMV) issued by competent authority.

**AGE LIMIT**

The candidates should not be less than 18 years of age and not more than 40 years of age as on 01.01.2026. Age relaxation shall be as per Govt. norms for reserved categories.

**Terms and Conditions:**

1. Candidates must be Indian Citizen as defined in Articles 5 to 8 of the Constitution of India.
2. The engagement shall be purely temporary and on contractual basis and doesn't entitle the person to be regularized in Govt. Service. After expiry of the contract period of 01 (One) year, the contractual agreement automatically stands terminated unless renewed by competent authority.
