**Terms & Conditions:**

1. Candidates must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. Candidates serving in Govt. Department should submit their application through proper channel.
3. Candidates must submit a copy of valid Driving License of LMV along with their application.

4. If any candidate is found to have suppressed his/her educational qualifications/age or given wrong information at the time or subsequent to applying for job, his/her candidature shall stand rejected without any information to him/her with immediate effect and shall also be liable to criminal Prosecution as per law.
5. Candidates must not be less than 18 years or more than 40 years of age on 01-01-2026. The upper age limit is relaxed by (copy of the certificate relating to reservation category issued by the competent authority must be submitted along with the application):
  - a. 5 (five) years for SC/ST candidates, i.e., 45 years;
  - b. 3 (three) years for OBC/MOBC candidates, i.e., 43 years.
