ID) and address proof along with 3 (Three) recent passport size photographs for filling up 01 (One) No. of post of Driver on (contractual) basis in the Office of the District Legal Services Authority, Baksa.-

Criteria for Applicant:

(a) Educational Qualifications: Minimum Class VIII passed.

(b) Other Qualifications: Having valid LMV Driving License.

(c) Age Limit: The candidate must not be less than 18 years and more than 40 years of age as on 01-01-2026. The upper age limit will be relaxed by:

1. By 5 years for Scheduled Tribe and Scheduled Castes i.e. up to 45 years as per Govt. Notification No.- ABP.6/2016/51, dated: 02-09-2020 issued by the Department of Personal, Government of Assam.

2. By 3 years for OBC/MOBC candidates i.e. up to 43 years as per Govt. Notification No.ABP.6/2016/51, dated: 02-09-2020 issued by the Department of Personal, Government of Assam.

How to Apply:

Applicants have to submit the filled up Standard Form along with all copies of self-attested documents like **Age proof Certificate, Educational and other qualification certificates, LMV Driving License, Caste Certificate, Experience Certificate** (if any), **Valid Employment Registration Certificate, Identity Proof** and **Address Proof** along with **03 (Three) Nos. of recent passport size photographs.**

In such cases, candidate shall have no right to claim for selection and same will be filled up as per decision of the Selection Committee and Committee decision will be the final.
