As per approval of the Hon'ble Executive Chairman, Assam State Legal Services Authority, Guwahati communicated vide letter no. ASLSA 192/2019/615 dated 19.03.2026 applications are hereby invited from eligible candidates in the prescribed Standard Form of Application published in Part-IX of the Assam Gazette for **hiring/engagement of 01 (one) no. of Driver on contractual basis in the establishment of District Legal Services Authority, Sribhumi, Assam at a monthly remuneration of Rs. 15,000/- (Rupees Fifteen Thousand)** only to be paid from NALSA Fund.

**Eligibility Criteria:**

1. The candidate must be a citizen of India as defined under Article 5-8 of the Constitution of India
2. The candidate must not be less than 18 years and not more than 40 years of age as on 01-01-2026. Upper age limit relaxation shall be as per existing Government Rule.
3. The candidate must possess a valid LMV Driving License issued by the Competent Authority and must have minimum 05 (five) years of driving experience of four-wheeler vehicle. Preference will be given to experienced candidates.
4. Only the candidates who have passed HSLC or equivalent examination from a recognized Board or Council shall be eligible to apply and those having higher qualification will be ineligible to apply.
5. The candidates must possess a valid Employment Exchange registration number.

**How to apply:**

6. The intending candidates must submit their application in Standard Form along with self-attested photocopies of LMV Driving License and all relevant testimonials relating to educational qualification, driving experience (if any), caste, age proof, employment exchange registration card, along with two copies of recent passport size photographs duly signed by the candidate on the reverse side.

The application in sealed envelope complete in all respect should be addressed to **The Chairman, District Legal Services Authority, Sribhumi, Town Kalibari Road, Near Head Post Office, PIN – 788710** and should reach the O/o the District Legal Services Authority, Sribhumi on or before **25.06.2026** till **5 PM** in the drop box, placed in the said office.
8. The candidates must mention their mobile no. having WhatsApp and email ID (if any) on the top of the application form.



9. The candidate serving in any Govt. Department must apply through proper channel.
10. The application will be received through **off-line mode only** and the last date of receipt of application is **25.06.2026 up to 5 PM**. No application will be entertained after the due date, and the appointing authority will not be responsible for any postal delay. The incomplete applications and those received in any other mode except as indicated above or without proper supporting documents or unsigned will be summarily rejected without any communication.

**Selection Procedure:**

11. Eligible candidates will have to appear for skill test and viva-voce.
12. After scrutiny of applications, accepted/rejected list of candidates will be uploaded in the official website of Sribhumi District Judiciary (<https://karimganj.dcourts.gov.in>) in due course of time.
13. The place, date and time of skill test and Viva-voce will be uploaded in the official website and no individual Call letter/Admit Card will be sent to the eligible candidates and the candidates are advised to check the official website of Sribhumi District Judiciary for getting updated information.
14. No TA/DA will be admissible to the candidates for appearing in the skill test and viva-voce.
15. Canvassing directly/indirectly in any form will disqualify the candidature of the candidate.
16. The Selection Board reserves the right to cancel, alter or modify the advertisement or other terms and conditions without any prior notice.
