The intending candidate shall submit the application in sealed envelope and addressed to the "Principal Judge, Family Court, Dhubri" and drop it in the "Drop Box" placed at the office of the Family Court, Dhubri (Ground Floor). Envelope must be superscribed "Application for the post of Driver" on the top.

GENERAL ELIGIBILITY CRITERIA:

- i. The applicant must be an Indian citizen as defined in Articles 5 to 8 of the Constitution of India.
- ii. The applicant must have passed class VIII standard to apply for the post.
- iii. The applicant must possess a valid Light Motor Vehicle (LMV) driving licence issued by the competent authority.
- iv. The applicant must not be less than 18 years or more than 40 years of age as on date of advertisement. Age relaxation is admissible as per Govt. Rules.
- v. Applicants who are already in Govt. service must produce a No Objection Certificate (NOC) from the employer.
- vi. The applicant shall submit self-attested photocopies of all relevant testimonials of educational qualification, driving licence, caste certificate, age proof certificate, employment exchange registration card, experience certificate (if any) etc. along with the application.
- vii. The applicant must have registered his/her name in the Employment Exchange and the registration must be valid on the date of submission of application.
- viii. The applicant shall submit 2 (two) recent passport size photographs along with the application.
- ix. The applicant shall produce the "Medical Fitness Certificate" at the time of viva voce /interview. Medical Certificate granted by a Govt. Medical practitioner shall be valid.
