Terms and Conditions:

1. **Age:** 35 to 62 years as on 01/01/2026; Age proof certificate to be submitted.
2. **Educational qualification:** The candidates shall have a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children or is a practicing professional with a degree in child psychology or psychiatry or law or social work or sociology or human health or education or human development or special education for differently abled children. Preference will be given to the Post Graduate degree holders in the mentioned subject.
3. **Experience:**
 - (i) has been actively involved in health, education or welfare activities pertaining to children for seven (7) years.
4. **Other Eligibility Criteria:**
 - (i) no person shall be eligible for selection as a Chairperson / Member / Social Worker of Committee or Board, if he/she
 - a. has any past record of violation of Human rights/Child rights.
 - b. has been convicted of an offence involving moral turpitude, and such

- conviction has not been reversed or has not been granted full pardon in respect of such offense.
- c. has been removed or dismissed from service of the Govt. of India or State Govt. or an undertaking or corporation owned or controlled by the Central or State Govt.
 - d. has ever indulged in child abuse or employment of child labour or has committed any immoral act or any other violation of human rights.
- (ii) A person associated with an organization receiving foreign contribution shall not be eligible to be a Chairperson or Member or Social Worker of the Committee or Board.
 - (iii) Any person working in the implementation of the Act in any Non-Government Organization or any organization, performing such functions which may cause conflict of interest in discharge of their duties as the Chairperson or Member or Social worker of the Committee or Board shall not be eligible for appointment as follows:
 - a. Any family member who is a member of any non-governmental organization;
 - b. Close relation with a member of any non-governmental organization;
 - c. Any persons working in a district for rescue and rehabilitation;
 - d. A person who representing / runs a Child Care Institution or Member of the Board or Trust of any non-governmental organization.
 - e. be associated with any Child Care Institution, directly or indirectly, during his tenure as a Member of the Board or Committee or have any other conflict of interest.
 - (iv) The candidate only from the concern district where the post is lying vacant will be eligible for apply.
5. Appointment of any Chairperson / Member / Social Worker of the Board or Committee shall be terminated by the Govt. after making an enquiry if he / she has been found guilty of misuse of power vested on them under this Act, if he / she
- a. has been convicted of an offence involving moral turpitude and such conviction has not been reversed or he/she has not been granted full pardon in respect of such offence.
 - b. fails to attend the proceeding of the Committee or Board consecutively for 3 months without any valid reason or fails to attend $\frac{3}{4}$ of the sittings in a year.
6. A Member / Chairperson / Social worker selected by the State Level Selection Committee should not:
- a. be holding such other full-time occupation that does not allow him to

- give necessary time and attention to the work of the Board or Committee.
- b. hold any office in any political party during his tenure, or
 - c. be insolvent
 - d. does not fulfill the qualifications and experience prescribed in the Act and rules made there under and in such a case, the Selection Committee, constituted under Rule 87 shall after due inquiry and on establishment of such fact, reject his application.
7. Any practicing lawyer / advocate selected for any of the positions in JJB or CWC shall be debarred from dealing with any case relating to children (below 18 years of age) during their tenure in CWC or JJB even in their personal capacity
 8. All selected Chairperson / Member / Social Worker of the Board or Committee shall have to undergo police verification and subject to submission of Police verification report within 15 days from the day of receipt of the selection notification, joining at concern Board or Committee will be confirmed.
 9. The Chairpersons or Members of CWC and Social Workers in JJB shall be paid as per Mission Vatsalya Guideline on per sitting basis (minimum 6 hours in a day).
 10. Willing and eligible applicants may submit their applications by **10th July, 2026** during office hours in the office of the District Child Protection Officer of the district concerned.
 11. Applications, complete in all respects, received in the respective districts shall be scrutinized by the District Level Scrutiny Committee (DLSC) by **25st July, 2026** and a panel of shortlisted candidates shall be prepared in the ratio of **1:3**. Thereafter, it will be placed before the State Level Selection Committee (SLSC), constituted under Rule 87 of the Juvenile Justice (Care & Protection of Children) Model Rules, 2022 for final Viva and selection. The State Level Selection Committee reserves the right to reject any application or recommendations made by the DLSC as and when required.
 12. The SLSC also reserves the right to review their own recommendation in case any complaints are received.
 13. The person applying for the post of the Chairperson or Member of the Committee shall submit an affidavit, as per Form 49 (enclosed), certifying that the applicant is not barred by any of the conditions laid down in sub-section 4A of section 27 of the Act.
 14. The person applying for the post of the Social Worker of the Board shall submit an affidavit, as per Form 49 (enclosed), certifying that the applicant is not barred by any of the conditions laid down in sub-section 4(4) (i-v) of the Act.

15. The applicant will submit Aadhaar Card along with the application as address proof.
