Terms & Condition for the positions:

- No separate call letter will be issued against the candidates
- No TA/DA will be paid for attending the Verification cum interview.
- The selected candidates (Warden cum Superintendent/ Head Teacher /Full Time Asstt. Teacher/) will have to reside in the School (KGBV).
- Relaxation of upper age limit will be applicable for SC, ST(P), ST(H), OBC & PH candidates as per Govt. of Assam OM No ABP 06/2016/04 dtd 03.03.2016.
- The engagement will be purely temporary and contractual basis.
