C. Eligibility Criteria:

1) Qualifying Age:

- * Candidate must not be less than 30 years as on 1st January, 2026.
- * Age limit of candidates will be calculated on the basis of Birth Certificate issued by the competent authority, HSLC Admit card/Certificates issued by recognised Board/Council.
- * No other documents shall be accepted in lieu thereof for the purpose.

2) Educational Qualification:

Candidates should be minimum 10th passed from Board/Institution recognised by the State/ Central Government.

3) Other Criteria:

- * Candidate should be a citizen of India and a permanent resident of the area in respect of which he/she seeks appointment.
- * Candidate should be physically fit and have sound mind.
- * Candidate should not have been declared as an insolvent or defaulter in payment of Govt. dues (furnish Bakijai Clearance Certificate).
- * Candidate should not be a government employee.
- * Candidate should not be a member of any political party.
- * Candidate should have land or immovable property in his/ her name in the area (village) in which he/she intends to be appointed as Gaon Pradhan.
- * Preference shall be given to the family members of Gaonpradhan and views of the Mouzadar shall be taken into consideration.
- * Candidate should be a person of high status and command and have a respectable position in the society.
- * Candidate should not have more than 2 (two) living children from a single or multiple partners (in cognizance to Government of Assam Notification dated 19th July, 2019 vide No. R.L.R. 187/ 2007/Pt./24).
- * Candidate should furnish a self-affidavit that the applicant does not have more than two living children from a single/multiple partners.

D. How to Apply:

- a) Candidates must submit their application in the prescribed Standard Form of application “Part IX of the Assam Gazette” only and no other form of application will be entertained.
- b) Candidates have to submit their duly filled application along with other documents in the Application receiving box to be kept in Land Revenue Branch of the Integrated District Commissioner Office, Kamrup, Amingaon (1st Floor) from the date of publication of this advertisement till 20th August 2026.
- c) The application must be accompanied by self-attested copies of the following documents:
 - ** Educational qualification Certificate, Mark sheet, Admit Card of HSLC.
 - ** Age proof Certificate (i.e birth Certificate issued by the competent authority or HSLC Admit Card/ Certificates issued by the recognized Board/Council).
 - ** Three recent passport size colour photographs of size 3.5 cm x 4.5 cm with white background.
 - ** PAN Card.
 - ** Voter ID Card.
 - ** Small Family Norms affidavit/Self Declaration stating that the applicant does not have more than 2 (two) living children from a single/multiple partners (as per Govt. Notification No.RLR.187/2007/ pt/24, Dtd.-19.07.2019.
 - ** Jamabandi in respect of the applicant or his/her parents of the concerned village against which he/she is applying for the post of Gaon Pradhan to show that he/she has land or immovable property in that village.
 - ** Mouzadar certificate confirming that the applicant belongs to the village where he/she is applying for the post of Gaon Pradhan.
 - ** Permanent Residence Certificate (PRC).
 - ** Self-declaration stating that he/she does not belong to any political party and not a government employee.
 - ** Bakijai clearance certificate.
 - ** Cast certificate (if any).

E. Period for receipt of application:

- Applications will be received from the date of publication of this advertisement up to 20.08.2026 during office hours.
- The date and venue of the Viva Voce Interview will be notified later on through the Circle offices and Mouzadar offices and District Commissioner, Kamrup office website (www.kamrup.assam.gov.in).

Note :

- Candidate must carry all testimonials in original and photocopy at the time of interview.
- No request for admission for participation in the interview on another day will be accepted in case candidate fails to attend the interview on the scheduled date.
- Eligible candidates scoring highest marks in the Viva Voce interview will be selected for the post of Gaon Pradhan for the concerned village.
- All appointment will be made after Police verification report as per procedure.
- The decision of the District Commissioner, as to the eligibility or otherwise of a candidate for admission to the interview venue shall be final.
