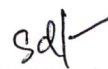

EMPLOYMENT NOTICE

Applications are invited in duly filled up Standard Form from the eligible candidates as published in (part-IX) Assam Gazette from citizens of India for filling up the following vacant post in the establishment of the Chief Judicial Magistrate, Dibrugarh.

1. The Candidates must possess the minimum qualification of Class VIII standard. The candidates who have passed HSSLC or above shall be ineligible to apply for the aforesaid posts. Candidates having special skills may be given preference on need basis.
2. Candidates must be an Indian Citizen as defined in the Article 5 to 8 of the Constitution of India.
3. Candidates already in service should apply through proper channel.
4. The Minimum age limit is 18 years and Upper age limit is 40 years for General Candidates, 43 years for OBC/MOBC Candidates, 45 years for SC/ST Candidates and 50 years for PwBD Candidates, (relaxable as per rules).
5. Candidates should have a valid Registration of Employment Exchange of Assam.
6. Application must be accompanied with self attested copies of all testimonials regarding education qualification, age, caste along with 2(Two) copies of recent passport size photographs self attested (one pasted and one stapled).
7. Eligible Candidates will have to appear in Viva-Voce test at a date which will be notified later on in our Official Website only (<https://dibrugarh.dcourts.gov.in/>). No separate Call letter will be issued. No T.A. / D.A. will be provided to the candidates for attending the viva-voce.
8. Envelope containing application should indicate the name of the post applied for on the top in block letters as – **“APPLICATION FOR THE POST OF _____”** and address to the **Chief Judicial Magistrate, Near Phoolbagan, A. T. Road, Dibrugarh – 786001**. The application form along with all testimonials may be dropped in the **Drop Box** in the Office of the Undersigned during office working hours as well as may be sent by **Post** to the address mentioned above.
9. Incomplete forms / applications are liable to be out rightly rejected.
10. The admission of candidates for the selection process will be purely provisional and subject to the satisfaction of the prescribed eligibility condition and final scrutiny of application and documents.
11. Last date of receipt of application in the Drop Box is 31.08.2026 up to 5 P.M. Drop Box will be closed after last date and time. The appointing authority shall not be responsible under any circumstances for postal delay.
