1. The Candidate must be an Indian Citizen as defined in Articles 5 to 8 of the Constitution of India.
2. The Candidate must have registered his or her name in the Employment Exchange and the registration number along with the dates must be mentioned in the Application Form.
3. Caste / Tribe certificate issued by the competent authority must be accompanied with the Application Form.
4. As per Govt. O.M. ABP-06/2016/51 dated 02/09/2020 candidates must not be less than 18 years or not more than 40 years of Age on 01-01-2026 The upper Age is relaxable in case of OBC/MOBC- 43 years of age and SC/ST(P) and ST (H) 45 years of age. Age proof supporting documents must be submitted with the application.
5. Candidates who are already in Govt. service may apply through proper channel. They shall have to produce "No Objection Certificate" from the present Employer at the time of document verification and they shall have to submit release order at the time of joining.
6. The post of "Office Peon" is purely temporary and may continue till the existence of Foreigners Tribunal. The employees shall have no claim to continue in service in case the Tribunals are abolished.
7. No T.A. / D.A. shall be paid to the candidates for appearing in the walk in interview.
